For exterior projects, this product must be used as a 2K coating. It is also recommended to use an impregnator along with the recommended 2K Waterborne Topcoat (6OWB045Gx0) for the best overall longevity of the project.

Do not use the product with temperatures below 15°C and when relative humidity is high since they affect dry times and stackability.

Surfaces finished with waterborne products should be cleaned with non-aggressive detergents (not containing acids, ammonia or bleach), without abrasive properties and solvent-free. Avoid the use of acetone or alcohol.
